Introduction

The Company is authorised by the Central Bank as an open-ended investment company with variable capital incorporated under the laws of Ireland as a public limited company pursuant to the Companies Act 2014 and the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended. The Company is organised as an umbrella fund with segregated liability between sub-funds.

The purpose of this letter is to notify you of a proposed change to the name of the Fund.

Change of Name

Subject to the approval of the Central Bank, it is proposed to change the name of the Fund in the manner set out below:

The rationale for the changes is to make clearer for the benefit of prospective and current Shareholders the assets in which the Fund is invested (i.e. China A shares). The investment objective and investment policy of the Fund are not affected by the proposed changes to the name of the Fund.
